Overall Objective:	The <b>overall objective</b> is to strengthen the civil society and capacities in two directions, including fight against corruption and an improved administration that is EU-compliant and more efficient.  The <b>specific objectives</b> are:  1. Increasing civil society efforts in fighting corruption through regular court monitoring  2. Advancing justice sector efforts in the implementation of confiscation and management of illicit wealth  3. Strengthening civil society's impact in PAR monitoring and awareness raising on PAR-related issues (ABR, efficiency, etc)  4. Increasing institutional accountability, efficiency and service delivery via awareness raising and informational campaigns
Project Purposes:	<b>First</b> , the project aims to support the rule of law and anti-corruption efforts through systemic monitoring, and by directly engaging in enhancing institutional accountability and transparency, all while increasing efficiency in the fight against corruption, confiscation and management of criminal assets. <b>Second</b> , the Action will directly engage in improving the pace of implementation of public administration reforms that is still slow and inefficient.
Project Strategy:	Within a period of 30 months (2.5 years), the Action will implement two (2) components that will be carried out by GLPS. Each component includes concrete activities that will be implemented during a given timeframe. The project is spread out into three (3) main phases: inception, implementation and conclusion. The inception phase will serve to design monitoring methodologies for both components, partnership agreements with relevant stakeholders, project dissemination to the public and overall designing of specific activities and outputs that will serve the end goal. The implementation period will be the longest and most intense in terms of activities and implementation. While the conclusion phase will serve for the finalization of all remaining activities and reports for the needs of the project, including the evaluation of the impact achieved. During the implementation period, particular focus will be put in advocacy and visibility activities, among others. Given this, a specific PR and visibility plan will be agreed at the inception phase and will be implemented until the end period.
